

# New AgriTourism Limited Liability Signs Are Now Available Protect Your AgriTourism Business Today!

Important legislation was passed by the state Legislature (SB 5808) that establishes that an agriTourism professional is not liable for unintentional injury, loss, damage, or death resulting exclusively from the inherent risks of an agriTourism activity, with certain exceptions. This new law went into effect on July 23, 2017.

To benefit from this new liability protection, you must post signs with the specific language shown in the sample to the right. WA Farm Bureau is making signs available that are 3' X 4' and comply with the new law. The sign is available in a high-quality poly-vinyl banner.

**The new law requires that these new signs be placed in a clearly visible location at the entrance to the agritourism business and at the site of each agriTourism activity.**
